These Terms of Business set out the rules for using our facilities, taking part in our classes, and maintaining membership with us. By joining The Gauntlet Fight Academy, booking a class, or using our premises, you agree to these terms.

1. About Us

We provide in-person multi disciplinary martial arts and fitness training for adults and children aged 4 and above.

2. Membership and Payments

- We offer both monthly membership and pay-as-you-go options.
- Memberships are paid monthly by Direct Debit, and are collected by Ashbourne
 Management unless otherwise agreed.
- Memberships may be cancelled by giving **30 days' written notice**, unless a different notice period is specified in your individual agreement.
- Fees are non-transferable and non-refundable except where required by law.
- It is your responsibility to ensure payments are made on time. Missed payments may result in late fees, suspension or cancellation of your membership.
- If you decide to freeze your membership, it is your responsibility to inform us if you wish to cancel or extend any freeze of your membership, otherwise your regular payments will resume as per your membership agreement.

3. Code of Conduct

All members, parents, and visitors are expected to follow **The Academy Code of Conduct**, which sets out our standards for behaviour, respect, hygiene, and safety. We aim to provide a positive and inclusive environment for everyone. The Academy reserves the right to:

- Refuse entry or participation to anyone who breaches the Code of Conduct.
- Suspend or cancel membership without refund in cases of serious or repeated misconduct.

A copy of the Code of Conduct is available at reception, on display in our changing rooms and on our website.

4. Health, Safety and Participation

- All students must complete and sign The Gauntlet Fight Academy Waiver before taking part in any class or activity.
- You are responsible for assessing your own health and fitness before participating.
- Martial arts training is a contact sport and carries an inherent risk of physical injury.
 By taking part, you acknowledge this risk and agree to train at your own risk.
- While The Academy takes all reasonable steps to ensure a safe training environment, we cannot accept responsibility for injuries that occur as part of martial arts or fitness training.
- If you feel unwell or injured, please stop training immediately and inform your instructor.

5. Personal Property

Please take care of your belongings.

The Academy **will not be held responsible** for any loss, theft, or damage to personal property on the premises.

6. Children and Young People

For students under 18:

- A parent or guardian must complete the waiver and consent form.
- Parents or guardians are responsible for ensuring their child's safe arrival, collection, and conduct while on the premises.

7. Changes to Classes and Timetable

We may occasionally need to:

- Change class times, instructors, or formats.
- Cancel sessions due to circumstances beyond our control (e.g. instructor illness, maintenance, events or public holidays).
 - We will give as much notice as reasonably possible, and where applicable, offer an alternative session.

8. Cancellations by the Academy

We reserve the right to cancel a membership or refuse admission at any time if:

- The Code of Conduct is breached.
- Fees remain unpaid.
- Behaviour is unsafe, disruptive, or disrespectful to staff or other members.

9. Limitation of Liability

- Participation in classes and use of our facilities is entirely at your own risk.
- You agree to **waive and hold harmless** The Gauntlet Fight Academy Ltd, its instructors, and staff for any injury sustained while training or using our premises.
- Nothing in these terms limits our liability for personal injury caused by our negligence.

10. Privacy and Data Protection

We respect your privacy.

Personal information is handled in line with our **Privacy Policy**, available on our website. We will never share your details with third parties without your consent, unless required by law.
