



The Gauntlet Fight Academy Equality Policy

Policy Objectives

The Gauntlet Fight Academy is fully committed to the principles of equality of opportunity and is responsible for ensuring that no job application, employees, workers, office holders, volunteers, participants or members (together 'Stakeholders') are unlawfully discriminated against because of age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation (together the 'Protected Characteristics').

In addition, The Gauntlet Fight Academy recognises that we live in a diverse society and will endeavour to ensure that all Stakeholders are given the same opportunities regardless of their socio-economic backgrounds. The Gauntlet Fight Academy will encourage partner organisations, affiliated associations, suppliers, sponsors and customers, to adopt and demonstrate their commitment to the principles and practice of equality as set out in this Equality Policy.

Purpose of the Policy

The Gauntlet Fight Academy recognises that individuals (and/or certain groups in our society who share one or more Protected Characteristics) may not have been able to participate equally and fully in sports related activities in the past. In some instances this may have been a result of unlawful discrimination. This Policy has been produced to try to prevent and address any unlawful discrimination or unfair treatment, whether intentional or unintentional, direct or indirect, against Stakeholders that may preclude them from participating fully in sports related activities.

Legal Requirements

The Gauntlet Fight Academy is required by law not to unlawfully discriminate against its Stakeholders and recognises its legal obligations under, and will abide by the requirements of, the Equality Act 2010, and any equivalent legislation (as amended) in any UK jurisdiction, Jersey, Guernsey or the Isle of Man and any later amendments to such legislation or subsequent equality related legislations that may be relevant to The Gauntlet Fight Academy. The Gauntlet Fight Academy will seek advice each time this Policy is reviewed to ensure it continues to reflect the current legal framework and good practice.

Discrimination, harassment, bullying and victimisation

The Gauntlet Fight Academy recognises the following as being unacceptable:

1. Unlawful discrimination which can take the following forms:

1.1. Direct Discrimination: treating someone less favourably than you would treat others because of a Protected Characteristic

1.2. Indirect Discrimination: applying a provision, criterion or practice which, on the face of it, applies equally to all but which, in practice can disadvantage individuals with a particular Protected Characteristic. Such requirements or conditions are lawful only if they can be objectively justified.

2. Harassment: engaging in unwanted conduct relating to a relevant Protected Characteristic or unwanted conduct of a sexual nature where the conduct has the purpose or effect of violating the recipients dignity or creating an intimidating, hostile, degrading, humiliating or offensive environment for the recipient, or any other individual affected by such conduct. The Gauntlet Fight Academy is committed to ensuring that its Stakeholders are able to conduct their activities free from harassment.

3. Bullying: the misuse of power or position to criticise persistently or to humiliate and undermine an individual's confidence.

4. Victimisation: subjecting someone to a detriment because he or she has in good faith taken action under the Equality Act 2010 (or equivalent legislation) by bringing proceedings, giving evidence or information in relation to proceedings, making an allegation that a person has contravened the Equality Act 2010 (or equivalent legislation) or doing any other thing for the purpose or in connection with the Equality Act 2010 (or any equivalent legislation).

5. The Gauntlet Fight Academy regards discrimination, harassment, bullying or victimisation, as described above, as serious misconduct. All complaints will be taken seriously and appropriate measures including disciplinary action may be brought against any Stakeholder who unlawfully discriminates against, harasses, bullies or victimises any other person.

Reasonable Adjustments

When any decision is made about an individual, the only personal characteristics that may be taken in to account are those that are consistent with any relevant legislation and are relevant to the substance of the decision being made. The Gauntlet Fight Academy recognises that it has a duty to make reasonable adjustments for disabled persons. The Gauntlet Fight Academy will consider all requirements and where possible will accommodate reasonable requests and will work with disabled Stakeholders to implement any adjustments that will enable them to participate more fully in sports related activities.

Responsibility, implementation and communication

The following responsibilities will apply:

The Gauntlet Fight Academy Management is responsible for ensuring that this Equality Policy is implemented, followed, and reviewed when appropriate. The Gauntlet Fight Academy Management is also responsible for ensuring that this Equality Policy is enforced and any breaches are dealt with appropriately

All stakeholders have the responsibility to respect, follow and promote the spirit and intentions of the Equality Policy. Individual work programmes for The Gauntlet Fight Academy staff will be amended to include equality related tasks where appropriate.

The Gauntlet Fight Academy will regularly review its employment practices to ensure continuing compliance with relevant legislation, and where possible good practice. All job packs sent out by The Gauntlet Fight Academy will contain a policy statement similar to the following: "Our policy is that no employee, member or applicant for this post receives less favourable treatment than another on the grounds of race, colour, ethnic, racial or national origins, religion (or religious belief), sex, marital status, sexual orientation, age or disability. Further, no person will be disadvantaged by any condition or requirement that is not justified by the genuine needs of the role or the Club.'. No applicant for any post (including job applicants, consultant advisers and suppliers) will be placed at a disadvantage by requirements or conditions which are not necessary to the performance of the job or which constitute unlawful discrimination. Consultants and advisers (and where appropriate suppliers) to The Gauntlet Fight Academy will be required to abide by this Equality Policy and it will be referred to in any service level agreements or contracts issued by The Gauntlet Fight Academy.

This Equality Policy will be communicated in the following ways:

1. The Policy will be included in any employee handbook (or equivalent paper or electronic document). Reference will be made to this Equality Policy in any code of conduct. This Equality Policy is for guidance only and will not form part of any contract of employment with any employees of The Gauntlet Fight Academy;
2. The Policy will be highlighted in all staff and volunteer inductions;
3. A copy of this Equality Policy will be publicly available on the The Gauntlet Fight Academy website and copies in other formats will also be available from The Gauntlet Fight Academy.
4. Each time this Policy is reviewed, The Gauntlet Fight Academy Stakeholders will be consulted. Following consultation, a notice of the changes being made will be publicly available and a direct communication will be sent to all those who contributed to the consultation process (subject to Data Protection provisions); and
5. The Gauntlet Fight Academy will promote continuing professional development for all employees and volunteers to support equal opportunities within the organisation and, where appropriate, provide specialist facilities, equipment or training. Actions The Gauntlet Fight Academy will produce, maintain and monitor an Equality Action Plan to ensure the objectives of this Equality Policy are consistently delivered throughout all areas of the organisation. The Gauntlet Fight Academy recognises that, in some cases, to further the principle of equality, an unequal distribution of resources may be required. If appropriate and proportionate, The Gauntlet Fight Academy London will consider positive action or may introduce special measures to assist any group with a Protected Characteristic which is currently underrepresented within any group of Stakeholders.

Monitoring and Evaluation

This Equality Policy will remain in force until it is amended, replaced or withdrawn. A review of this Equality Policy will take place as and when required, but not less than once every three years.

Complaints Procedures

To safeguard individual rights under this Equality Policy, any Stakeholder who believes they have suffered inequitable treatment within the scope of this Equality Policy may raise the

matter through the appropriate procedure (i.e. the employee grievance procedure for employees or the conduct and complaints procedure for Stakeholders who are not employees).

Appropriate disciplinary action will be taken against any Gauntlet Fight Academy Stakeholder who violates this Equality Policy under the employee disciplinary procedure or Conduct and Complaints Policy and procedures. An individual raising an employee grievance will not be penalised for doing so unless it is untrue and not made in good faith.
